International Modern Hospital Show

Tokyo, JAPAN: July 14th – 21st, 2014

The Government of Alberta – International and Intergovernmental Relations Northeast Asia Branch welcomes your participation in the 2014 Alberta Health Technology Mission to Japan. The mission includes attendance at the annual **International Modern Hospital Show** held in Tokyo, Japan with a possible extension to other cities in Japan or Taiwan.

The Trade Show attracts representatives from the Health Technology sector with over 360 companies in medical equipment, products related to rehabilitation in nursing medical information services and hospital / facility management support related products and services, ICT health solutions aiming at further developing medical technology.

Alberta Health Technology Companies at the Show are welcome to:

- Participate in showcasing your company at a dedicated Alberta booth at the Trade Show;
- The booth will be equally shared among the Alberta exhibitors at no additional cost;
- Use the booth for meetings, as a contact point and a base of operations;
- Meet with potential business partners, manufacturers, suppliers, importers and local industry associations;
- Language support.

*Maximum of six companies on a first-come-first-served basis. Priority will be given to export-ready Alberta life science companies.

Potential Opportunity to Visit Other Cities in Japan or Taiwan

There is also the possibility of extending the trade mission to other cities in Japan and/or Taiwan. The purpose is for companies to learn about doing business in Japan, Taiwan and other Asia regions to possibly meet with industry representatives and potential partners. If a sufficient number of applicants express a desire to visit other Asia regions, the Government of Alberta Trade Mission will be extended.
